

Now Available: Amendments to the Office of Developmental Programs' (ODP) Waivers Approved by the Centers for Medicare and Medicaid Services (CMS) ODP Announcement 23-085

PURPOSE:

The purpose of this communication is to inform all interested parties that the Consolidated, Community Living, P/FDS and AAW amendments were approved by CMS and become effective November 1, 2023. The waiver amendments are available on the Department of Human Services' (DHS) website.

DISCUSSION:

The Office of Developmental Programs (ODP) is pleased to announce that the

amendments to the Consolidated, Community Living, P/FDS, and Adult Autism Waivers were approved by CMS on October 18, 2023. The amendments are effective November 1, 2023. As communicated in ODP Announcement 23-070, the waiver amendments were submitted to CMS on July 25, 2023. Since that time, ODP has been engaged in ongoing discussions with CMS. The following are examples of changes that were made after the amendments were submitted to CMS:

The unduplicated number of participants served in the Community Living Waiver
has been increased to accommodate the 750 additional people to be served in
the waiver as approved in the budget for Fiscal Year (FY) 23/24.
The unduplicated number of participants served, and number of participants
served at any point in time in the AAW has been increased by 5 to ensure there
are enough spaces in the waivers to serve those individuals for whom capacity
will be reserved when they require services in a long-term structured residence.
The new Specialty Telehealth and Assessment Team service will be implemented
in March 2024 in the Consolidated, Community Living, and P/FDS Waivers.
Information to protect each individual's privacy during the telehealth assessment
and a requirement for the provider to develop a summary of their role in service
delivery to share with other health care professionals involved in the individual's
care was added to the service definition.

Community Living, and P/FDS waivers and a home modification covered through the AAW. As Pennsylvania works on implementing coverage of Home

Accessibility durable medical equipment through Medical Assistance, ODP has received clarification that handrails that are considered a structural home

modification do not meet the definition of equipment and appliances and are

not covered through Medical Assistance.

The proposed Recovery and Expansion Supplemental Payments for Community

Participation Support (CPS), Supported Employment, Benefits Counseling, Small Group

Employment and Supports Coordination in the Consolidated, Community Living and

P/FDS Waivers were also approved by CMS in these amendments. For those providers

that submitted applications for these payments, ODP will be reviewing utilization and

billing data in the coming weeks and calculating payment amounts. It is expected that

payments will be processed no later than December 31, 2023.

All waiver changes submitted to CMS in July were approved.
